WEBTHE NEED TO SAY YES TO MENTAL HEALTH CRISIS REFERRALS, INCLUDING WORKING WITH PERSONS OF VARYING AGES (AS ALLOWED BY FACILITY LICENSE) AND CLINICAL CONDITIONS (SUCH AS SERIOUS EMOTIONAL DISTURBANCE, SERIOUS MENTAL ILLNESS, INTELLECTUAL AND DEVELOPMENTAL DISABILITIES), REGARDLESS OF ACUITY, INFORMS PROGRAM STAFFING, PHYSICAL SPACE,

**EUROPEAN CONVENTION ON HUMAN RIGHTS - EUROPEAN COURT ...**

WEBTHE PRINCIPLE OF SUBSIDIARITY, HAVE THE PRIMARY RESPONSIBILITY TO SECURE THE RIGHTS AND FREEDOMS DEFINED IN THIS CONVENTION AND THE PROTOCOLS THERETO, AND THAT IN DOING SO THEY ENJOY A MARGIN OF APPRECIATION, SUBJECT TO THE SUPERVISORY JURISDICTION OF THE EUROPEAN COURT OF HUMAN RIGHTS ESTABLISHED BY THIS CONVENTION, HAVE AGREED AS FOLLOWS ...

WEBOTHER PERSON WITH THE RESPONSIBILITY FOR THE CARE OF CHILDREN VOLUNTEER OR PERSONNEL OF A COMMUNITY SERVICE PROGRAM THAT OFFERS SUPPORT SERVICES FOR FAMILIES IN CRISIS TO ASSIST IN THE DELEGATION OF ANY POWERS REGARDING THE CARE AND CUSTODY OF A CHILD BY A PROPERLY EXECUTED POWER OF ATTORNEY PURSUANT TO SECTIONS 475.600 TO 475.604

WEBREQUIRES APPLICANT(S) TO DISCLOSE ANY CRIMINAL CONVICTIONS. IDENTIFIES THE PERSON AUTHORIZED BY THE LICENSEE TO ACCEPT RESPONSIBILITY FOR THE FACILITY IN THE LICENSEE'S ABSENCE. IDENTIFIES THE ORGANIZATION OF A CORPORATION, THE BOARD OF OFFICERS, AND ANYONE HAVING A BENEFICIAL OWNERSHIP OF 10 PERCENT OR MORE IN THE CORPORATION.
